This is to inform you that the shareholders of the Company in their 19th Annual General Meeting held on 29th September 2014 have approved the following:

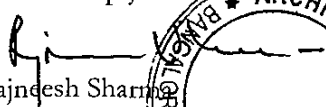

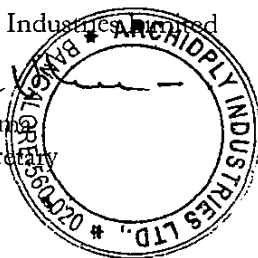
