Dear Sir/Madam,

This has reference to our earlier intimation dated June 26, 2026, wherein it was communicated that the Trading Window for dealing in the securities of the Company shall remain closed with effect from Wednesday, July 1, 2026, till 48 hours after the declaration of the Unaudited Financial Results for the quarter ended June 30, 2026.

In this regard, we would like to reiterate that the Company, vide its letter dated July 1, 2026, has formally intimated the Exchange regarding its decision to discontinue the voluntary submission of quarterly financial results and switch back to the statutory half-yearly financial disclosure cycle as per Regulation 33(5) of the SEBI (LODR) Regulations, 2015, applicable to SME-listed entities.

Consequent to this change in the compliance cycle, the financial results for the quarter ended June 30, 2026, are not required to be considered or approved by the Board of Directors.
