Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

Dear Sir,

Pursuant to Regulation 30 of SEBI Listing Regulations, we would like to inform that BSE Limited (“BSE”) have, vide their email/letter dated November 16th, 2023, imposed a late fees of Rs. 2000 plus GST on the Company under Regulation 13(3) of the SEBI Listing Regulations for Non-submission of Investor Complaint for the quarter ended on 30th September, 2023.

We wish to clarify that on 11th October, we diligently submitted the Investor Complaint on both platforms of the exchanges. Unfortunately, during the submission process on the BSE portal, a technical glitch occurred, leading to the sudden disappearance of the screen upon clicking the submit button. At that moment, we believed the data had been successfully submitted, as acknowledgments sometimes generate later on. Simultaneously, we completed a successful submission on the NSE portal on same day and time.

It's crucial to emphasize that our actions were not intended to mislead the Bombay Stock Exchange or our esteemed shareholders. The oversight in submitting to the BSE portal was solely due to unforeseen technical challenges. This incident was purely a result of a technical error.

The Company remains committed to ensure optimum compliances of all applicable laws and this is our first encounter with such an issue.

Furthermore, we wish to inform you that the Company has corresponded with BSE, providing detailed justifications and requesting the exchange for fair consideration in this matter.

The details as required under SEBI Listing Regulations read with Circular no. SEBI/HO/CFD/CFD-PoD1/P-CIR//2023/123 dated July 13, 2023 are enclosed as Annexure I.
