GCC steps up monsoon preparedness in Anna Nagar

Chennai, Sept 10: Greater Chennai Corporation has directed officials to expedite ongoing stormwater drain works in Anna Nagar zone as part of preparations for the northeast monsoon.

Central region deputy commissioner H R Kaushik inspected stormwater drain works at Bricklin Road in Ward 96 and at Second and Third Avenues and 10th Main Road in Ward 103 on Monday.

During the inspection, Kaushik reviewed the progress of the works and instructed officials to complete them at



the earliest to ensure that the drains are ready ahead of the northeast monsoon. The inspection was part of GCC's monsoon preparedness measures aimed at improving drainage and preventing waterlogging in vulnerable areas. Corporation officials accompanied the deputy commissioner during the inspection.

Rs. 12 lakh subsidy for mushroom cultivation

Ranipet, Sept 10: Farmers in Ranipet district can avail subsidies ranging from Rs 1,500 per hectare for integrated nutrient and pest management to Rs. 12 lakh for setting up mushroom production units under the National Horticulture Mission for 2026-27.

Collector N Priya Ravichandran said eligible farmers would be selected on a priority basis under the Mission for Integrated Development of Horticulture (MIDH) and could approach their respective block horticulture offices to apply.

Among the major components, private mushroom production units are eligible for a 40% subsidy of up to Rs. 12 lakh, while low-cost or small-scale mushroom units can receive a 50% subsidy of up to Rs. 1 lakh.For vegetable cultivation, a subsidy of Rs. 24,000 per hectare is available for tomato, chilli, brinjal, bhendi and vine vegetables. Farmers taking up high-density mango and guava cultivation can receive Rs 48,000 per hectare. The assistance is Rs. 30,000 for conventional mango cultivation, Rs. 18,000 for papaya, Rs. 26,400

for banana and Rs.30,000 for lemon.

Flower growers cultivating rose, chrysanthemum, jasmine and marigold can receive Rs. 20,000 per hectare. Under aromatic and spice crops, Rs. 20,000 per hectare is available for coriander and Rs. 40,000 for turmeric.

Individual farmers can receive a 50% subsidy of up to Rs. 90,000 for water-storage structures. Protected cultivation is also covered, with assistance of Rs. 355 per sq metre for shade-net structures, Rs. 20,000 per hectare for plastic mulching, Rs. 10,000

per hectare for crop-support structures and Rs. 25,000 per hectare for fruit protection covers. Weed mats are eligible for 50% assistance at Rs. 25 per sq metre.

Farmers can get Rs. 50,000 towards permanent vermicompost units and Rs. 8,000 for vermicompost beds. Bee boxes with colonies are eligible for a 40% subsidy of Rs 1,600 each, while Rs 8,000 is available for beekeeping equipment.

The scheme also provides Rs. 5,000 per farmer to cover the full cost of a five-day training or exposure visit within the state. Small vendors

can receive a 50% subsidy of up to Rs. 15,000 for mobile vegetable vending carts to sell produce directly to consumers.The collector urged eligible farmers to contact their block horticulture offices and apply for the schemes relevant to their crops and activities.

Demolish unsafe buildings if owners fail to act: Chennai Corporation

Chennai, Sept 10: Owners of structurally unsafe buildings in the city will have to carry out repairs or demolish them within the stipulated time, failing which the Greater Chennai Corporation (GCC) will pull down the structures and recover the demolition cost from them.

The civic body has issued detailed guidelines to identify and act against dilapidated buildings that pose a threat to occupants, pedestrians and residents of neighbouring properties. The guidelines will apply to both private and government buildings. Under the new procedure, Divisional Assistant Engineers and Junior Engineers have been directed to identify dangerous buildings during routine inspections

and report them to senior officials. The structures will subsequently be jointly inspected by the assistant engineer, assistant executive engineer and executive engineer to assess their age, condition and the extent of structural deterioration.

Where GCC engineers are unable to conclusively determine the structural stability of a building, the matter will be referred to the Public Works Department, Anna University or IIT Madras for a structural stability assessment.

If the expert report recommends repairs, the owner will be directed to complete them within a reasonable period depending on the nature and extent of work. Approval from the respective regional joint

or deputy commissioner must be obtained before such a notice is issued.

If the assessment recommends demolition because the structure poses a danger, GCC will issue a notice to the owner under Section 258 of the Chennai City Municipal Corporation Act. A copy of the notice and the structural assessment report will also be served on tenants.

If the owner fails to comply with the demolition notice, the corporation will demolish the building and recover the expenditure from the owner.

Officials have also been instructed to verify whether disputes between owners and tenants over the property or building are pending before courts. Any directions issued by

courts must be strictly followed.

The guidelines also provide for police

assistance to remove persons who refuse to vacate a structure declared dangerous, as part of

measures to prevent risks to occupants, passersby and neighbouring residents.
