Collector inspects PM-JANMAN housing project in Tiruvallur Dist

Tiruvallur, May 13: Tiruvallur collector M. Prathap, conducted a field inspection of houses being constructed under the PM-JANMAN scheme and other housing initiatives in Kadambathur and Tiruvallur Panchayat Unions. He directed officials to ensure that all works are completed swiftly and with high quality standards.

During the inspection in Kadambathur Panchayat Union, at Panappakkam village in Senji Panchayat, the Collector reviewed the construction of 62 houses being built at an estimated cost of Rs.2.92 crore. This includes 47 houses under the PM-JANMAN scheme and 15 houses under the Kalaingar Housing Scheme,

primarily benefiting the Irular

community. At Satharai Panchayat, he inspected 102 houses being constructed at a cost of Rs. 5.06 crore, comprising 94 houses under the PM-JANMAN scheme and 8 under the Kalaingar scheme. Similarly, at Vellerithangal Panchayat, he reviewed 24 houses being built under the PM-JANMAN scheme at an estimated cost of Rs.1.22 crore.

The Collector also inspected 51 houses under construction at Melakondaiyur Panchayat in Tiruvallur Panchayat Union, with a total project cost of Rs.2.60 crore.

He instructed Rural Development officials to complete all housing units promptly and hand them

over to beneficiaries without delay. Additionally, he emphasized the need to provide essential infrastructure, including roads, electricity connections, streetlights, and uninterrupted drinking water supply through overhead tanks and pipeline systems.

Senior officials, including Assistant Executive Engineer Govendan, Block Development Officer Ravi, Assistant Director (Panchayats & Audit) K.S. Yuvaraj, and Block Development Officer Elangovan, along with other Rural Development Department staff, accompanied the Collector during the inspection.



Cuddalore Collector Cibi Adithya Senthil Kumar, chaired a review meeting with departmental officials on land survey and records works at the District Collectorate meeting hall on Tuesday.
