1	Details of any change in the status and/or any development in relation such Proceedings	<p>The Hon'ble Madras High Court has pronounced the Order today, i.e., August 26, 2025, in Contempt Petition No. 3238 of 2024. It has directed the Company to produce before the Court the music log pertaining to SIMCA members for the period August 2010 to December 2020 and compute the royalty payable at the needle-per-hour rate, as stipulated under the individual agreements with SIMCA members, and furnish such calculation to the Court. The Hon'ble Court has directed to comply with the aforementioned directions within four weeks from the date of pronouncement of this Order and has listed the matter on September 26, 2025.</p> <p>However, there is no direction in the Order requiring the Company to make any payment either to the petitioner or to the Court at this moment.</p> <p>The Company will be filing an appeal against the said order before the appropriate forum.</p>
