Details of the transactions are as follows:

- Average Purchase Price: Rs. 69.00 per share
- Total Transaction Value: Rs. 1,10,400
- Percentage of Shareholding Traded: 0.022% of the paid-up share capital

The transaction value for securities traded under the promoter and their relatives does not exceed Rs. 10,00,000/- (Rupees Ten lakhs) in value, therefore Regulation 7(2) of Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015 is not applicable.

The total change in shareholding is 0.022%, which does not fall in any of the below-mentioned provisions i.e.

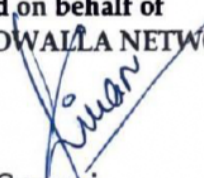
- Increase in shareholding from 5% or more
