Dear Sir/ Madam,

This is with reference to our letter no. DOMS/SE/25-26/60 and DOMS/SE/25-26/61 dated October 24, 2025 and October 28, 2025, respectively, wherein it was, inter alia, informed that DOMS Industries Limited (**'the Company'**) had received a Show Cause Notice (**'the said notice'**) on October 22, 2025, from Office of the State Taxes Officer, Kashmir and subsequently an Order passed by Office of the State Tax Officer, State Tax Department, Enforcement South Kashmir (**'the said impugned order'**), alleging transporting taxable goods without cover of specified documents.

In continuation to the above, the Company has made the payment of penalty levied under the said impugned order under protest and has received the release order from Office of the State Taxes Officer, Kashmir. The Release Order was received by the Company on October 29, 2025.

The relevant details as per the requirement of Regulation 30 of SEBI LODR Regulations, read with SEBI Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 is enclosed in '**Annexure - A**'.
