Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Imposition of fine by NSE & BSE for the quarter ended 30th June 2026

Dear Sir/ Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ["SEBI (LODR)"], it is to inform that National Stock Exchange of India Limited ("NSE") and BSE Limited ("BSE") have levied fine of Rs. 9,00,340/- each (incl. GST) on the Company for the non-compliance with Regulation 17(1), 18(1) and 19(1)/(2) of the SEBI LODR for the quarter ended 30th June 2026.

2. In this connection, we submit that the above non-compliance with respect to the Composition of the Board are beyond the control of the Company. RailTel Corporation of India Ltd. ("the Company/RailTel") is a Government Company as per provisions of the Section 2(45) of the Companies Act, 2013, and in terms of the Articles of Association of the Company, the President of India vests with the power to appoint Directors (including Independent Director) on the Board of RailTel. All Directors in RailTel are appointed by the Government of India through its Administrative Ministry, Ministry of Railways (MoR) and RailTel has no role to play in the appointment of any Director. Requests have already been made from time to time to the MoR for the appointment of requisite number of Directors including Independent Directors on the Board of the Company.
