Sub: Outcome on litigations / disputes

In terms of Clause 8 of Para B, Part A of Schedule III, read with Regulation 30 of SEBI (LODR) Regulations, 2015, and Circular No: SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated 11<sup>th</sup> July 2023, we have made disclosures on ongoing material litigations vide our letter dated 14<sup>th</sup> August 2023. We would like to provide the outcome with regard to following point provided in Annexure of the said letter:

Point (a) of Annexure i.e 'Disallowance of CENVAT Credit on Outward Freight'

We would like to inform that the Company's appeal before CESTAT on this subject matter, was remanded back to Original Authority, viz. Additional Commissioner of GST and Central Excise, Madurai, vide CESTAT orders dated 10<sup>th</sup> July 2024 and 4<sup>th</sup> September 2024. Subsequently, upon hearing, the Original Authority, vide its order dated 31<sup>st</sup> March 2025, dropped further proceedings. Hence, the issue is resolved to an extent of Rs.1.64 Crores on this subject matter. The order was received by the Company on 1<sup>st</sup> April 2025 at 6:30 PM by E-Mail.
