Point (e) of Annexure i.e 'Certain revenue expenditure treated as Capital expenditure by the Income Tax Department'

We would like to inform that the Income Tax Department has filed an appeal before Honourable Madras High Court against the order of Income Tax Appellate Tribunal (ITAT) passed on 17/04/2025 for the assessment year 2011-12. The disputed tax value is Rs.7.35 crores. The appeal was admitted by Honourable Madras High court on 13/11/2025.

Point (f) of Annexure i.e 'Industrial promotion Assistance treated as taxable income by the Income Tax Department instead of capital receipt'

We would like to inform that the Income Tax Department has filed appeal before Honourable Madras High Court against the order of Income Tax Appellate Tribunal (ITAT) passed on 17/04/2025 for the assessment year 2011-12 for the above issue. The disputed tax value is Rs.3.76 crores. The same was admitted by Honourable Madras High court on 13/11/2025 and
