Brief Details of the Litigation	<p>The Department had initiated re-assessment proceedings under Section 147 of the Income Tax Act, 1961 [Act] and issued notice to the Company under Section 148 of the Act, for a value of Rs.1,46,23,500/-, towards certain disallowances, for the assessment year 2017-18, vide communication dated 6.3.2024.</p> <p>Subsequent to this, the Company had made its submissions and on 24.03.2025, while the subject disallowances was reduced to Rs.8,58,687/-, the department has passed the re-assessment order and issued a demand notice for Rs.57,96,18,138/-.</p> <p>While passing the order under Section 147 of the Act, the Department has committed a mistake apparent on record in taking the assessed income as per the Original Assessment</p>
