Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we wish to inform you that a chargesheet has been filed under section 420 and 34 of Indian Penal Code before the Hon'ble Metropolitan Magistrate, 18th Court, Mumbai, against the Company and few of its Directors including two Independent Directors. The complaint was filed by one of the customer of the Company named Mr. Hitesh Mehta, Proprietor of M/s. Vinayak Infosolutions, Mumbai at Dr. D. B. Marg Police Station, Mumbai.

The Company strongly denies the claims made against it and is taking the necessary legal steps in the said matter. The details as required under Regulation 30 of the Listing Regulations are as under:

The Company categorically denies the allegations made in the complaint, which appear to be baseless, frivolous, and devoid of merit. Based on preliminary legal advice, the charges appeared to lack substance and are not tenable.

Furthermore, based on current evaluation, we do not foresee any material adverse impact on our financial position, operations, or overall business.

Additionally, we also hereby wish to inform that the Company has filed a case against the said customer under section 138 of Negotiable Instruments Act, 1881 on 19th October, 2023 for recovery of its legitimate dues against the goods supplied. The principle receivable in the case being to tune of Rs. 1.38 crore. However, the said amount is also not material in terms of Regulation 30 of SEBI Listing Regulations.

The Company will continue to disclose any material developments in said matter in accordance with the Listing Regulations.
