The aforesaid order has confirmed the demand by Office of Principal Commissioner of Customs amounting to Rs. 8,02,01,938/- (Rupees Eight Crores Two Lakhs One Thousand Nine Hundred Thirty Eight only) with applicable interest thereon, as following:
