***(a) Whether such negotiations were taking place? If so, you are advised to provide the said information along with the sequence of events in chronological order from the start of negotiations till date.***

**Ans.:** The Company evaluates various strategic opportunities in the ordinary course, for growth and expansion of its business. At this stage, there is no material event/ information that requires disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"). With respect to the statements made in news article, we confirm that these are speculative in nature and the Company does not endorse the contents of the referenced media article. Except first statement of the Article, rest of the information given in the Article are statements of facts known to the market.
