Sub: Exchange Query - Financial Results

Dear Sir/Madam,

We refer to your email dated June 13, 2025, seeking clarification from the Bank regarding the submission of the Audited "Summarized" Statement of Assets and Liabilities for Standalone and Consolidated basis for the quarter and year ended March 31, 2025. In this regard, we wish to state that the Board at its meeting held on April 25, 2025, based on the recommendation of the Audit Committee, considered, approved the Audited Standalone, and Consolidated Financial Statements of the Bank. These statements consist of the Balance Sheet as of March 31, 2025, the Profit & Loss Account, and the Cash Flow Statement for the year ended on March 31, 2025, along with notes to accounts.

Thereafter, the Bank submitted the Financial Results, including the Audited Standalone and Consolidated Summarized Statement of Assets and Liabilities for the quarter and year ended March 31, 2025, pursuant to the relevant provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Please note that although the Bank used the term "Summarized" while furnishing the Audited Standalone Summarized Statement of Assets and Liabilities for the quarter and year ended March 31, 2025, the Bank has provided all the required details in the format as prescribed by SEBI's Master Circular dated November 11, 2024. There was no inadequacy or incomplete disclosure in the submitted information. The Bank has used word "Summarised" as the Statement of Asset and Liabilities as presented and reported only presents key heads that are reported on the face of the Balance sheet. Sub-heads of Asset and Liabilities are reported in schedules of the Balance sheet, do not get reported in this Statement of Assets and Liabilities and hence the usage of word "Summarised".

The Bank has taken note of this query and concern and would omit the word "Summarised" henceforth while presenting the Statement of Assets and Liabilities in half yearly financial disclosures.

Hope the above clarifies. Humbly request you to kindly consider our submission.
