Pursuant to Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, we would like to inform you that OMCs [Indian Oil Corporation Limited (IOCL), Hindustan Petroleum Corporation Limited (HPCL), Bharat Petroleum Corporation Limited (BPCL)] has opened a tender vide EOI no OMC/EOI/BD/OCT25 (CYCLE1) Tender ID - 2025\_MKTHO\_187178\_1 dated 20<sup>th</sup> October, 2025 for supply of Biodiesel for the period of November 2025 to March 2026.
