In continuation to our earlier intimation dated August 03, 2026 and Pursuant to Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, we would like to inform you that OMCs [Indian Oil Corporation Limited (IOCL), Hindustan Petroleum Corporation Limited (HPCL), Bharat Petroleum Corporation Limited (BPCL)] has opened a tender vide EOI no OMC/EOI/BD/JUN26 (CYCLE1) Tender ID - 2026\_MKTHO\_ 190226\_1 dated 15<sup>th</sup> June, 2026 for supply of Biodiesel for the period of June 2026 to August 2026.
