Pursuant to Regulation 30 read with sub-clause 20 under Para A of Part A of Schedule III of the Listing Regulations, this is to inform you that during a routine compliance review conducted through a consultant, it has come to the Company's notice, based on information available on the official website (<https://www.infocredit.com.cy>) of the Department of Registrar of Companies, Cyprus, that the status of Reliance Telecom Infrastructure (Cyprus) Holdings Limited, a foreign step-down subsidiary of the Company, has changed from "**Active**" and is now reflected as "**Dissolved.**"

The Company is currently in the process of examining the implications of the aforesaid dissolution and evaluating any necessary actions which may need to be taken in this regard.
