Please note that in continuation of our earlier intimation submitted on May 27<sup>th</sup>, 2025, pursuant to the Consolidated Financial Results for the 4<sup>th</sup> Quarter & year ended on March 31<sup>st</sup>, 2025, were submitted with inadvertent clerical & typographical error which has resulted in a net decrease in the net profit after tax by Rs. 24 lakhs (Rupees Twenty Four Lacs Only). There is no impact in the Standalone Financial Statements arising out of the above error.

We humbly submit that above are inadvertent typographical errors & a modified XBRL file of the above results is already resubmitted on BSE Limited & National Stock Exchange of India Limited, respectively.

Also, opinion of our Statutory Auditors, i.e. Ashwani & Associates, Chartered Accountants, having FRN :000497N, is same as earlier, which is unmodified.
