Dear Sir / Madam,

In furtherance to our earlier announcement dated February 04, 2025, it is hereby informed that Care Health Insurance Limited (CHIL), a material subsidiary company of Religare Enterprises Limited, the listed entity, (REL/Company), has received a stay order from the Hon'ble Bombay High Court with respect to the writ petition filed against the order-in-original issued by the Office of the Assistant Commissioner of Goods And Services Tax, Faridabad on the SEZ matter for FY 2017-18 to 2023-24 under sections 74 of the CGST Act, 2017 (“the Act”), raising the GST demand of Rs. 17,68,26,837 with interest under section 50 of the CGST Act, 2017 read with section 20 of the IGST Act, 2017 and imposing penalty of Rs. 17,68,26,837 under section 74 of the CGST Act read with section 122 of the CGST Act, 2017 for various states. The impugned order refers to matters, which are relating to industry wide issues.

In this regard, we wish to inform you that the CHIL has received an order dated March 26, 2026, from its tax advisors on March 28, 2026, passed by the Hon'ble High Court, granting a stay on the impugned order till the final disposal of the Writ Petition.
