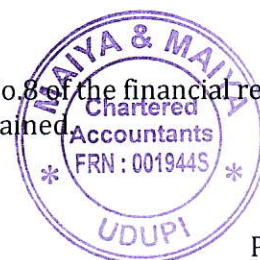

1. We have reviewed the accompanying statement of unaudited standalone financial results of **MAHA RASHTRA APEX CORPORATION LIMITED** ("the Company") for the quarter ended December 31, 2020 and year to date from April 1, 2020 to December 31, 2020 ("the statement"), being submitted by the company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
2. This Statement which is the responsibility of the Company's management and approved by the Company's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 'Interim Financial Reporting' ('Ind AS 34'), prescribed under section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a conclusion on the Statement based on our review.
3. We conducted our review of the statement in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A Review is limited primarily to Inquiries of company personnel and an analytical procedure applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

#### **Basis for Qualified Opinion**

4. We draw attention to:
  - a. The Company has Not provided for Delayed Period Interest cost for the quarter amounting to ₹ 18.77 Lakhs and from April 1,2020 to December 31,2020 is ₹ 56.04 Lakhs to that extent profit is overstated and Liability is understated.
  - b. Investment in one of Associate, Kurlon Limited Not shown at fair value as at 31<sup>st</sup> December 2020, in absence of quarterly reviewed statement, we are unable to quantify the effect on the value of Investment and Other comprehensive Income and corresponding figures are incomparable.
  - c. No Provision is made for Income tax as stated in Note No.8 of the financial results. The Impact thereof on financial for the quarter is not ascertained.





**Qualified Conclusion**


5. Based on our review conducted as stated in paragraph 3 above, nothing has come to our attention except as stated in the 'Basis of qualified opinion' above that causes us to believe that the accompanying statement of unaudited standalone financial results, prepared in accordance with the recognition and measurement principles laid down in the applicable Indian Accounting Standards ('Ind AS') specified under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other recognised accounting practices and policies has not disclosed the information required to be disclosed, in terms of Regulation 33 of the Listing Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.

**Emphasis of Matter:**

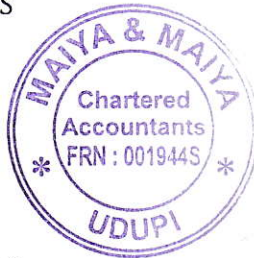
6. We Draw attention to following matters:
- We draw attention to Note 2 of the accompanying standalone financial results, as regards the management's evaluation of uncertainties related to COVID-19 and its consequential effects on the results as at 31<sup>st</sup> December 2020 and operations of the Company
  - As per the scheme sanctioned by Honourable High Court of Karnataka vide order dated 8th October 2004 all Deposit/ Bonds should have been repaid by 15.06.2009. The balance outstanding as on date are shortfall of repayment is ₹ 4,895.50 Lakhs.
  - RBI has cancelled the Certificate of Registration Granted to the company to Act as Non-Banking Financial Company by its order dated 13th June 2002.
  - Unpaid creditors being outstanding Bonds / Deposit with Interest under Other Financial Liability- Current Includes ₹ 572.15 Lakhs, Deposit Bonds Pending Realisation year wise/ Instalment wise reconciliation not produced for verification.
  - Company entered in to agreement for Sale of Property with Kurlon Limited Total amount Credited up to 31-12-2020 is ₹.1273.37 Lakhs. Out of which ₹. 300.95 Lakhs Kurlon Limited Directly settled Maha Rashtira Apex Bonds / Deposit liability is also adjusted towards Advance for Property purchase.

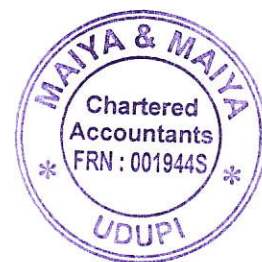

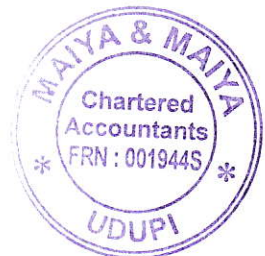
5. Basis for Qualified Conclusion:

- a. *It has been explained to us that the financial statement of one Associate, Kurlon Limited is still under compilation, Accordingly Not forming part of consolidated financial results. Its impact on consolidated profit and Investment in Associates is not quantified corresponding figures incomparable.*
- b. We draw attention to standalone financial statement, which indicate that:

The company has not provided for delayed period interest for the quarter amounting to ₹ 18.77 Lakhs and Year to date up to December 31,2020 amounting to ₹ 56.04 Lakhs to that extent profit is overstated and liability is understated.

6. Qualified Conclusion

Based on our review conducted as above, nothing has come to our attention except as For the possible effect of the matters described in paragraph 5 - 'Basis of qualified opinion' above nothing further has come to our attention that causes us to believe accompanying statement of unaudited Consolidated financial results, prepared in accordance with the recognition and measurement principles laid down in the applicable Indian Accounting Standards ('Ind AS') specified under Section 133 of the Companies Act, 2013, as amended read with relevant rules issued thereunder and other recognised accounting practices and policies has not disclosed the information required to be disclosed, in terms of Regulation 33 of the Listing Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.



**7. Emphasis of Matter**

We Draw attention to Stand alone financial statement which includes following matters:

- Refer to Note No 2 of accompanying consolidated Financial Results, The Group has assessed the uncertainty Impact of COVID - 19 and its consequential effects on the results as at 31<sup>st</sup> December 2020 and operations of the Company
- As per the scheme sanctioned by Honourable High Court of Karnataka vide order dated 8th October 2004 all Deposit/ Bonds should have been repaid by 15.06.2009. The balance outstanding as on date are shortfall of repayment is ₹.4,895.50 Lakhs.
- Company entered in to agreement for Sale of Property with Kurlon Limited Total amount Credited up to 31-12-2020 is ₹.1273.37 Lakhs. Out of which ₹. 300.95 Lakhs Kurlon Limited Directly settled Maha Rashtra Apex Bonds / Deposit liability is also adjusted towards Advance for Property purchase.

Our Conclusion is not modified in respect of (a) and (b) above


**8. Other Matter**

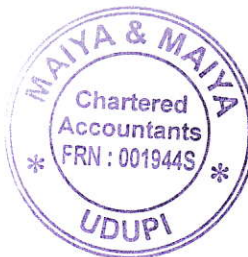
