Sub: Resignation as Statutory Auditor of Rite zone Chemcon India Limited

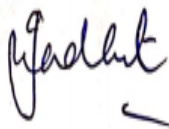

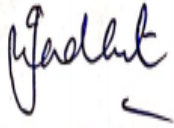
