Based on our review conducted and procedures performed as stated in paragraph 3 above and based on the consideration of the review reports of other auditors referred to in paragraph 6 below, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standard specified under section 133 of the Companies Act, 2013, as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of the Regulation, read with the Circular, including the manner in which it is to be disclosed, or that it contains any material misstatement.
6. We did not review the interim financial results and other financial information, in respect of Five subsidiaries, whose interim financial results/information reflects total revenue of Rs. 318.55 Crores, total profit/(loss) after tax of Rs. 8.61 Crores and total comprehensive income of Rs. 13.20 Crores for the Quarter ended June 30, 2025, as considered in the consolidated unaudited financial results. These interim financial results and other financial information have been reviewed by other auditors, whose reports have been furnished to us by the management. Our conclusion, in so far as it relates to the affairs of such subsidiaries is based solely on the report of other auditors. Our conclusion is not modified in respect of this matter.
7. We did not review the interim financial results of Six subsidiaries considered in preparation of the Statement, whose interim financial results/ informations reflects total revenue of Rs. 79.78 Crores, total profit/(loss) after tax of Rs. (2.82) Crores and total comprehensive income of Rs. (2.82) Crores for the Quarter ended June 30, 2025 as considered in the consolidated unaudited financial result which are solely based on financial results certified by the management.



According to the informations and explanations given to us by the management, these interim financial results and other financial information are not material to the Group. Our conclusion on the Statement is not modified in respect of the above matter.
