Please refer to your e-mail dated 17.11.2020, we hereunder submit the details sought for;

- 1) The subject Licence is issued by the Excise Department, Puducherry for manufacture of Indian Made Foreign Liquors (IMFL) at the factory premises at R.S. 89/4-A, Katterikuppam Village, Mannadipet Commune, Puducherry – 605 502.
- 2) This Licence enables the listed entity to manufacture IMFL at the said premises – viz Factory at R.S. 89/4-A, Katterikuppam Village, Mannadipet Commune, Puducherry – 605 502.
- 3) The Excise Licence has been cancelled by the Excise Authorities on the allegation was inadequate holograms fixing in the IMFL bottles. However, the alleged reasons for cancellation of manufactory licence on the grounds of irregularities in affixture of holograms are unlawful. The company is taking all immediate steps with the Authorities to revoke the cancellation order. The cancellation of the Manufactory Licence issued to manufacture IMFL at the factory premises at R.S. 89/4-A, Katterikuppam Village, Mannadipet Commune, Puducherry – 605 502 may impact on going concern status. The company is taking all immediate steps with Authorities to revoke the cancellation order.
- 4) The Licence was issued on 14.05.1999 with yearly renewal clause, which was renewed and valid till date of cancellation.
