The Board of Directors of the Company at their meeting held on 13th November, 2025, approved the proposal to conduct a Postal Ballot (Remote e-voting only) pursuant to Section 110 and all other applicable provisions, if any, of the Companies Act, 2013, read together with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force) ("Rules"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "SEBI Listing Regulations"), General Circular Nos. 14/2020 dated April 08, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 05, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 08, 2021, 3/2022 dated May 05, 2022, 11/2022 dated December 28, 2022, 09/2023 dated September 25, 2023, 09/2024 dated September 19, 2024 and 03/2025 dated September 22, 2025 issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars"), Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and any other applicable law, rules and regulations (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force), to seek approval of the Members for the following Ordinary Resolution:

- To consider and approve appointment of Mrs. Shanmugam Vidhyasankari (DIN: 06869213) as Non-Executive Non-Independent Director of the Company.

The Board of Directors of the Company appointed Mr. Uttam Shetty, Proprietor of M/s. Uttam Shetty & Co. (Membership No. FCS 8691 & Certificate of Practice No. 16816), Mumbai, Practicing Company Secretary, as Scrutinizer for conducting the Postal Ballot process (through remote evoting only) in a fair and transparent manner.

The summary of conduct of Postal Ballot is as under:

a) The Notice of Postal Ballot containing instruction was sent on Saturday, 15th November, 2025 through Company's Registrar and Share Transfer Agent i.e. KFin Technologies Limited ("KFintech") by way of electronic mode only (i.e. e-mail) to those Members whose names appeared on the Register of Members/List of Beneficial Owners as on Friday, 14th November, 2025 ("Cut-off Date") and whose email addresses were registered with the Company/Depositories on the said date in compliance with the said MCA Circular.

- b) The Public Notice of Postal Ballot and Remote E-voting Information was published in the newspapers i.e. Business Standard (English newspaper) and Makal Kural (Tamil newspaper) on Monday, 17th November, 2025.
- c) The Company had engaged the services of KFin Technologies Limited for the purpose of providing e-voting facility to all its Members.
- d) The remote e-voting period commenced on Tuesday, the 18th November, 2025 (9:00 a.m. IST) and concluded on Wednesday, the 17th December, 2025 (5:00 p.m. IST).
- e) On the conclusion of the remote e-voting period, Mr. Uttam Shetty submitted his Scrutinizer's report thereon dated 17th December, 2025 in the prescribed format to the Company.
- f) The Result of the Postal Ballot was declared on 18th December, 2025 and intimated to the stock exchanges and uploaded on the website of the Company and KFin Technologies Limited.
