11. The Board reviewed the progress of the Company.

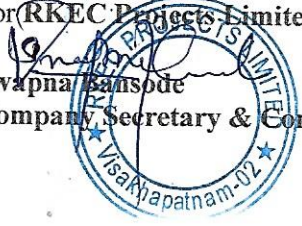
