अनुसूचित जातीसाठी एकूण ८ जागा, त्यापैकी ४ महिलांकरिता, अनुसूचित जमातीसाठी १ जागा, नागरिकांचा मागास प्रवर्गासाठी एकुण १७ जागा, त्यातील ९ महिलांसाठी, तसेच सर्वसाधारण गटाकरिता एकण ३९ जागा असून, त्यातील १९ जागा महिलांसाठी आहेत. एकुण ६५ जागांपैकी ३३ जागा महिलांकरिता आरक्षित असणार आहेत, अशी माहिती आयुक्त श्री. नार्वेकर यांनी

महापालिकेच्या निवडणकीकरिता ३४३ मतदान केंद्रे स्थापन केली जाणार आहेत. चार सदस्यीय प्रभागात ३११ मतदान केंद्रे असून, पाच सदस्यीय प्रभागात ३२ मतदान केंद्रे असणार आहेत. निवडणुकीकरिता राज्य निवडणुक आयोगाने इलेक्ट्रॉनिक्स मतदान यंत्र उपलब्ध केली असून, त्याप्रमाणे ३८० कंट्रोल युनिट, १ हजार १४० बॅलेट युनिट व ३८० मेमरी उपलब्ध

एकूण पाच निवडणूक निर्णय अधिकारी, १२ सहाय्यक निवडणुक निर्णय अधिकारी, ३५ झोनल अधिकारी, ४५ मास्टर ट्रेनर्स तैनात करण्यात येणार असून, मतदान केंद्रांवर ३८० केंद्राध्यक्ष, प्रत्येकी ३ झोनमध्ये ३८० मतदान अधिकारी तैनात करण्यात आले आहेत. अशी मोठी यंत्रणा कार्यान्वित करण्यात आली असून, निवडणूक खर्चावर लक्ष ठेवण्यासाठी यासाठी पथके नियुक्त केली आहेत.

निवडणुकीचा कार्यक्रम निश्चित झाला आहे. या निश्चित कार्यक्रमानुसार एकुण १६ प्रभागांसाठी १५ जानेवारीला मतदान होणार आहे. त्यासाठी १ जुलै २०२५ च्या मतदार याद्या ग्राह्य धरण्यात येणार आहे. २३ डिसेंबरपासून सकाळी ११ ते दुपारी ३ या वेळेत ३० डिसेंबरपर्यंत उमेदवारी अर्ज स्वीकारले जाणार आहेत. या उमेदवारी अर्जाची ३१ डिसेंबरला छाननी होणार असून, त्यानंतर अंतिम उमेदवारांची लगेचच यादी प्रसिद्ध केली जाणार आहे.
