As you are aware, we were appointed as the Statutory Auditors of the Company for the FY 2023-24 to FY 2027-28 at the Annual General Meeting of the Company held on 30th September, 2023.

We hereby inform you that, due to the expiration of our peer review certificate on 31st August 2024, we are unable to continue in our capacity as peer-reviewed auditors for the Company.
