Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that the Board of Directors of RNFI Services Limited ("Company"), at its meeting held today, i.e. September 05, 2026, took note of the internal transfer of Mr. Sameer Nagpal, presently serving as Group Chief Operating Officer ("COO") and Key Managerial Personnel ("KMP")/Senior Management Personnel ("SMP") of the Company, to Ambition Services Private Limited, a Group Company of RNFI Services Limited, effective close of business hours of September 5, 2026.

Ambition Services Private Limited, recently acquired by the Company, has demonstrated a significant operational turnaround within a short span since acquisition. Given Mr. Nagpal's extensive leadership experience within the Group, the Board has decided to deploy him as Chief Executive Officer of Ambition Services Private Limited to lead its next phase of expansion and consolidation, and to stabilise the entity's leadership until a permanent CEO is identified

Consequent to this internal transfer, Mr. Nagpal will no longer hold the designations of Group Chief Operating Officer ("COO") and KMP/SMP of the Company with effect from the close of business hours of September 5, 2026, and shall be re-designated as KMP/SMP of the Company at such time as he is transferred back to RNFI Services Limited.
