With reference to our **earlier intimation** dated 2nd September 2024 (enclosed herewith as per Annexure -B), we had informed that a demand of ₹17,00,819/- was issued by the Office of the Deputy/Assistant Commissioner, CGST & CX, Kirti Nagar to RNFI Services Limited on 30th August 2024 & the Company has filed an appeal before the Appellate Authority challenging the said demand.

We would like to provide an update that in response to above mentioned appeal, the Appellate Authority has **quashed the original demand of ₹17,00,819/-** and issued a revised final demand of ₹23,066/- to RNFI Services Limited (enclosed herewith as per Annexure -A).
