This is to inform you that pursuant to the letter dated July 16, 2025, of the Investor Education and Protection Fund Authority ("IEPFA"), Ministry of Corporate Affairs, the Company has initiated the "**100 Days Campaign – Saksham Niveshak**" from July 28, 2025 to November 06, 2025, for the shareholders whose dividends are unpaid/unclaimed.
