Note: 1. The above financial results were reviewed by the Audit Committee and approved by the Board of Directors of the Company on 16th May 2026. The Statutory Auditor has issued a modified opinion on the audited financial results.  
 2. The audited financial results have been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standards, prescribed under Section 133 of the Companies Act, 2013 and all other accounting principles generally accepted in India, in the event applicable.  
 3. Corporate Insolvency Resolution Process (CIRP) and the appointment of Resolution Professional were admitted in the case of one of the customers of the Company by the Hon'ble National Company Law Tribunal, Chennai Bench (Hon'ble Justice V.S. Sudhakar) vide order dated May 5, 2020. The settlement process under Section 124 of the Insolvency and Bankruptcy Code, 2016 was approved with 100% majority vote by the Committee of Creditors (CoC) and the Insolvency Resolution Professional (IRP) on 16/05/2020 dated December 28, 2023. The balance outstanding as on March 31, 2025 amounted to INR 308 Lakhs. During the previous year, the Company had received part repayment along with accrued interest and the required amount for the balance outstanding amount was repaid up to March 31, 2026. The said balance amount of INR 308 Lakhs has subsequently been received by the Company on 13/05/2026 along with applicable interest. Accordingly, management is of the opinion that no material uncertainty exists as regards recovery of the aforesaid amount.  
 4. The Company has given Inter-Corporate Deposit (ICD) of Rs. 200 Lakhs to M/s. Aranyo Exports Private Limited on July 4, 2017. However, the Company has not received interest on ICD till date. Therefore, no accrued interest on ICD has been recognised in the books of accounts for the financial year 2025-26. This is a matter of satisfaction by the auditor, based on disclosures with the customer, that full repayment of the outstanding receivable from the said customer is expected to happen this year a matter of satisfaction by the auditor.  
 5. Accrued interest on loans and advances receivable on the above-mentioned loans has been carried out of outstanding values. However, no provision has been made in the books of accounts based on the profitable terms. Management is of the opinion, based on disclosures with the customer, that full repayment of the outstanding receivable from the said customer is expected to happen this year a matter of satisfaction by the auditor.  
 6. The Company is engaged in the non-Banking Financial Company (NBFC) activities. Both in the current and previous financial years, the Company was issued a rating of 'BBB+' by CRISIL. In accordance with the 45th Amendment to the Companies Act, 2013, the Company has obtained only one corporate default (i.e. NBFC activities) from the rating agency. The Company has not obtained any other default from the rating agency for separate reporting, an additional segment.
