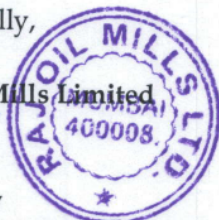


Due to unforeseen reasons, the proposed inter-se transfer will not be proceeding as initially planned.
