Form IEPF, SRN: T75383299 dated 31st January, 2022

We are in receipt of your letter dated 8th January, 2024 on the above subject and noted carefully your various allegations against us, without knowing the facts fully. We vehemently deny all such allegations and take exception to the same. We take this liberty to give hereunder our comments on each of the Paragraph of the letter under reference:

- 1. The Screen Status is still reflecting the PEVR-** The Screen Shot sent by you was seen by you as on 31st January, 2022. The re-submission was already done on 15th December, 2022. (Copy of receipt enclosed Annexure 1). The delay in such re-submission is fully attributable to you as the required document for the purpose as required by IEPF authorities were submitted by you only on 22nd November, 2022 and received by us on 29th November, 2022 (copy enclosed as Annexure 2), There is a series of mails in this regard and we are avoiding to refer to those mails and blame game. Post resubmission the status was changed to WORK IN PROGRESS till the status has changed again as SENT FOR RESUBMISSION. The reasons for such re-submission are still not clear. It only says that Certificate/ Letter not available. (Screen Shot enclosed as Annexure 3). IEPF authorities took time and still did not specify the exact nature of the deficiency. We wonder how the Company be held responsible for something, which is beyond their control. Under the circumstances, your repeated remark to make the Company responsible is uncalled for and needs to be withdrawn forthwith.
- 2. Despite several reminders and communications the Company did not submit the Revised Verification Report-** This is NOT a correct statement based on facts on record. The reality is we always acted in the best possible manner, provided due care and sincere efforts to resolve the matter, but unfortunately the matter is still pending WITHOUT any fault of the Company. The ethos of our Company is to attend to our esteem shareholders forthwith and resolve their grievances/ issue in the best possible manner in the given circumstances and without any delay of any nature whatsoever, unless we are compelled by factors beyond our means in meeting our aforesaid objective. You may recall that your 2 similar cases have been resolved and your claim admitted by IEPF authorities, which could be possible only because of our fullest co-operation and attending to the claims in the manner required.
- 3. The Company shall be personally liable:** We strongly object to your this remark and clarify that the Company is in no way responsible to indemnify any person for any loss or consequences to which he/ she may be subjected to as a consequence of being the





shareholder. In the instant case we are nowhere at fault and therefore, there is no question of our accepting any liability to you in any manner. In any case, we also reserve our right to defend ourselves in all the legal proceedings and act in the manner as may be advised in accordance with applicable laws.

4. **Company to submit the revised Verification Report-** YES. Undoubtedly we shall do that provided we are made aware about the deficiency in our earlier Report. Kindly advise us the same if IEPF authorities have notified you. No such mail has ever been received by us after submission of our last Report.

Under the Circumstances, you will appreciate that there has always been fullest co-operation from our end with the good intention of getting your claim admitted by IEPF and you would humbly withdraw all derogatory remarks/ allegations against us.
