रिलायंस इंडस्ट्रीज लिमिटेड और उसकी भागीदार बीपी पीएलसी ने शुक्रवार को केजी-डी6 ब्लॉक में एमजे तेल एवं गैस क्षेत्र से नियमित उत्पादन शुरू होने की घोषणा की। इसके साथ ही भारत में स्वच्छ ईंधन का उत्पादन 10 करोड़ घनमीटर प्रतिदिन से अधिक हो जाने की उम्मीद है। एमजे क्षेत्र पूर्वी तट से दूर केजी-डी6 ब्लॉक-98/3 या केजी-डी6 ब्लॉक में खोजों का तीसरा और आखिरी खंड है, जिस पर यह गठजोड़ काम कर रहा था।

कॉकपिट में अनधिकृत व्यक्ति का प्रवेश रुके

नागर विमानन महानिदेशालय (डीजीसीए) ने शुक्रवार को एयरलाइन कंपनियों को नियमों का पालन सख्ती से करने और पायलटों व चालक दल के अन्य सदस्यों को यह सुनिश्चित करने के लिए कहा कि कॉकपिट में अनधिकृत व्यक्ति का प्रवेश नहीं हो। डीजीसीए का यह निर्देश हाल ही में सामने आए उन मामलों के संदर्भ में आया है, जिनमें उड़ान के दौरान विमान के कॉकपिट में अनधिकृत व्यक्तियों ने प्रवेश किया था। नियामक ने एक परामर्श जारी करते हुए सभी एयरलाइन के परिचालन प्रमुखों को 'उचित कदम उठाते हुए ऐसे मामलों की पुनरावृत्ति रोकने' के लिए कहा है। परामर्श में कहा गया है कि नियमों का पालन नहीं करने पर, कॉकपिट में अनधिकृत प्रवेश के मामले में सख्त कार्रवाई की जाएगी।

ई-दोपहिया का पंजीकरण घटा

जून में इलेक्ट्रिक दोपहिया वाहनों के पंजीकरण में दिखी तेज गिरावट

नई दिल्ली, 30 जून

इलेक्ट्रिक दोपहिया वाहनों का पंजीकरण जून में सभी कंपनियों के मामले में तेजी से गिरकर 42,124 रह गया है, जो मई में 1,01,140 के रिकॉर्ड पंजीकरण का मात्र 40 प्रतिशत है।

पिछले महीने कंपनियों ने 1 जून से पहले अपना स्टॉक खत्म करने के लिए आक्रामक तरीके से कदम उठाया था, जब उन्हें सरकार की फास्टर एडॉप्शन ऐंड मैनुफैक्चरिंग ऑफ (हाइब्रिड ऐंड) इलेक्ट्रिक व्हीकल्स (फेम 2) योजना सब्सिडी में कमी की भरपाई के लिए कीमतें बढ़ानी पड़ी थीं।

उद्योग का अनुमान है कि दामों में तेज वृद्धि से वित्त वर्ष 24 में कुल बिक्री पर असर पड़ेगा, जो 10 से 12 लाख के बीच रह सकती है। यह इस वित्त वर्ष के अंत तक नीति आयोग के 24 लाख के अनुमान की तुलना में आधे से भी कम है। वित्त वर्ष 23 में उद्योग ने 7.5 लाख वाहन बेचे।

एक प्रमुख इलेक्ट्रिक स्कूटर कंपनी के अधिकारी ने कहा कि कीमतों में बढ़ोतरी के कारण 30 फीसदी ऐसे संभावित ग्राहक, जो पहले की कीमत पर इलेक्ट्रिक वाहन खरीदे लेंगे, बाजार से बाहर हो गए हैं। अधिकारी ने कहा कि वे केवल तभी



वापस आएंगे, जब हम अपने स्कूटरों के साधारण संस्करणों को पहले वाली कीमत के आसपास पेश करेंगे। उन किफायती मॉडलों को सामने लाने में हमें कुछ महीने लगेंगे, इसलिए हमें त्योहारी सीजन से पहले इसके सामान्य स्तर तक जाने की उम्मीद नहीं है।

कार्यकारी ने कहा कि उन्हें नहीं लगता कि वित्त वर्ष 2024 में बाजार 10 लाख से अधिक तक पहुंच पाएगा, जो सरकार और उद्योग दोनों के ही अनुमानों की तुलना में काफी कम है।

सोसाइटी ऑफ मैयूफैक्चरर्स ऑफ इलेक्ट्रिक व्हीकल्स के महानिदेशक

सोहिंदर गिल ने भी यही विचार व्यक्त किया। उन्होंने कहा कि यह प्रवृत्ति त्योहारों के सीजन के दौरान स्थिर होने या बढ़ने से पहले अल्पावधि में जारी रहेगी। लेकिन संभावित नुकसान तब तक पूरा नहीं होगा, जब तक सरकार एक या दो साल के लिए सब्सिडी बजट को तीन गुना नहीं कर देती और सब्सिडी बैकलॉग का भुगतान नहीं कर देती। उन्होंने कहा कि हालात बेहतर हो जाते, अगर सब्सिडी वितरण अवरोध हों और विवाद को हल करने में विफलता के कारण हल्की श्रेणी वाले सेगमेंट को बाजार से बाहर नहीं जाना पड़ता।

इस सिकुड़ते बाजार के पंजीकरण में जून में ओला इलेक्ट्रिक और एथर एनर्जी का योगदान 50 प्रतिशत से अधिक रहा। मई की तुलना में ओला का पंजीकरण 43 प्रतिशत घटकर 16,332 वाहन रह गया। बजाज ऑटो जैसी पहले से मौजूद कंपनी का मई में शानदार अनुभव रहा, जब उसका इलेक्ट्रिक स्कूटर पंजीकरण पहली बार 10,000 का आंकड़ा पार कर गया, लेकिन इसके बाद जून में गिरावट का सामना करना पड़ा और पंजीकरण घटकर केवल 2,672 वाहन रह गया। टीवीएस का पंजीकरण एक-तिहाई तक लुढ़क गया।

इलेक्ट्रिक दोपहिया वाहन श्रेणी 15 महीने के निचले स्तर पर

इस साल जून में 42,124 वाहनों की बिक्री के साथ इलेक्ट्रिक दोपहिया वाहन श्रेणी 15 महीने के निचले स्तर पर पहुंच गई है। पिछली बार उद्योग ने इससे कम बिक्री फरवरी 2022 में दर्ज की थी, जब 35,721 वाहन बेचे गए थे। बिक्री पिछले महीने दर्ज किए गए 1,05,348 के सर्वकालिक शीर्ष स्तर से 60 प्रतिशत कम हो चुकी है। जून महीने में गिरावट के बावजूद इस साल के पहले 6 महीने में 71,888 वाहनों की औसत मासिक बिक्री अब भी पिछले साल दर्ज 52,593 की बिक्री से अधिक है। शीर्ष सात कंपनियों की रैंकिंग में बदलाव हुआ है, लेकिन अभी तक एक भी कंपनी इस सूची से बाहर नहीं हुई है। सबसे बड़ी गिरावट ओकिनावा के मामले में हुई है, जो 2022 के दूसरे पायदान से गिरकर 2023 में सातवें पायदान पर आ गई है।

फर्मों ने विदेशों से जुटाई 12 प्रतिशत ज्यादा रकम

भारतीय कंपनियों ने विदेशी स्रोतों से कैलेंडर वर्ष 2023 की पहली छमाही में 12 प्रतिशत अधिक धन जुटाया है और यह राशि बढ़कर 9.7 अरब डॉलर हो गई है, जबकि वर्ष 2021-22 की समान अवधि में 8.6 अरब डॉलर जुटाया गया था। बदली हुई भू-राजनीतिक परिस्थितियों और बढ़ती ब्याज दरों के बावजूद रिलायंस इंडस्ट्रीज की अगुआई में कई कंपनियों ने विदेशों से धन जुटाया। विदेशों से पैसा जुटाने की कवायद के सलाहकार प्रबल बनर्जी ने कहा कि भारत में कई कंपनियां धन जुटा रही हैं क्योंकि उनके नकदी प्रवाह में सुधार हुआ है और रुपये पर आधारित बॉन्ड में मयुचुअल फंड का पर्याप्त पैसा निवेश किया जा रहा है।

विलय-अधिग्रहण में आई 76 फीसदी कमी

मुंबई, 30 जून

भारत में 2023 की पहली छमाही में विलय और अधिग्रहण के सौदों में खासी कमी आई है। इस दौरान विलय और अधिग्रहण 76 फीसदी घटकर 3.2 अरब डॉलर रहा। ब्लूमबर्ग के आंकड़ों के मुताबिक इस साल जनवरी से जून के बीच कुल 1,201 सौदों की घोषणा की गई जबकि 2022 की पहली छमाही में 13.42 अरब डॉलर मूल्य के 1,914 सौदे किए गए थे।

विलय एवं अधिग्रहण गतिविधियों में ऐसे समय में गिरावट आई है जब बीते बुधवार को शेयर बाजार रिकॉर्ड नई ऊंचाई पर पहुंच गया और मुख्य कार्याधिकारियों को उम्मीद है कि आर्थिक गति आगे भी बरकरार रहेगी। ब्याज दरों में बढ़ोतरी के अलावा अमेरिका की शार्टसेलर फर्म हिंडनबर्ग रिसर्च द्वारा अदागी समूह पर नकारात्मक रिपोर्ट जारी करने समूह के पंजीकरण में भी कमी आई है। ऐसे में अदागी समूह ने नकदी बचाने की खातिर विलय एवं अधिग्रहण गतिविधियों से थोड़ी दूरी बना ली है। पिछले साल मई में अदागी समूह ने 10.5 अरब डॉलर में अंबुजा सीमेंट्स का अधिग्रहण किया था।

अभी तक घोषित प्रमुख सौदों में कनाडा की पेंशन प्लान इन्वेस्टमेंट बोर्ड द्वारा 4 अरब डॉलर में रीन्यू पावर में हिस्सेदारी खरीदना शामिल है। उसने गोल्डमैन सैक्स से रीन्यू पावर में 51.6 फीसदी हिस्सेदारी खरीदी है। इसके अलावा टेमासेक ने मनिपाल हास्पिटल्स में 2 अरब डॉलर के निवेश से अपनी हिस्सेदारी बढ़ाकर 59 फीसदी की ली।

एयरलाइन के मुख्य मानव संसाधन अधिकारी सुरेश दत्त त्रिपाठी ने सकुलर जारी किया, जिसमें कहा गया है, 'नई जिम्मेदारियों और पदों के साथ नया संगठनात्मक ढांचा जवाबदेही के संदर्भ में स्पष्टता, दक्षता, कामकाजी सहयोग और हमारे कर्मचारियों के विकास को ध्यान में रखकर तैयार किया गया है।'

त्रिपाठी ने कहा कि पुराने और नए ग्रेड ढांचे के बीच कोई समानता नहीं है।

उन्होंने कहा कि सालाना वेतन वृद्धि का लाभ उन्हीं कर्मियों को मिलेगा, जो 8 अक्टूबर, 2021 और 31 दिसंबर 2023 के बीच एयरलाइन से जुड़े हैं। वहीं निजीकरण से पहले शामिल हुए कर्मियों के लिए उनके वेतन अब फिक्स्ड पे और परफॉर्मेंस-लिंकड बोनास के साथ कोस्ट-टु-कंपनी (सीटीसी) ढांचे पर आधारित होंगे।

त्रिपाठी ने कहा कि जिन कर्मचारियों ने स्वेच्छिक सेवानिवृत्ति के लिए आवेदन किया है, उन्हें भी संशोधित रोजगार अनुबंध और वेतन नहीं मिलेंगे।

एयर इंडिया मौजूदा समय में प्रति सप्ताह करीब 2,945 उड़ानें संचालित कर रही है।
