With reference to our Tender enquiry and your offer under reference cited above, we are pleased to award the work of "Supply, Erection, Testing, Commissioning and Certification of 1 Number of Kone/Johnson/ OTIS/ Mitsubishi/Schneider make Stretcher cum Passenger elevator (Capacity 1360 Kg and G+6 levels) for service building including Civil, Aesthetics and Electrical work in NNTPS" to you. To enable you to proceed with the work, some of the important conditions are given below:

- 1.0 Scope of work: Scope of work covers "Supply, Erection, Testing, Commissioning and Certification of 1 Number of Kone/Johnson/ OTIS/ Mitsubishi/Schneider make Stretcher cum Passenger elevator (Capacity 1360 Kg and G+6 levels) for service building including Civil, Aesthetics and Electrical work in NNTPS." Detailed Scope of work as mentioned in the tender, vide Ref (1) cited above.
- 2.0 Contract value: Rs. 1,43,41,000/- (Rupees One Crore Forty Three Lakhs Forty One Thousand only Including applicable GST) Including GST. Work Schedule is attached separately.
- 3.0 **Period of Contract:**

18 months from the date of LOA

4.0 **Price Reduction Clause:**

For Supply portion, Erection & Commissioning:

Time is the essence of the contract. In case the contractor fails to complete the works within the stipulated period (as per Clause No. 7.2, 7.2.1 of LOA Order), then, unless such a failure is due to Force Majeure or due to Purchaser's defaults, the total contract price shall be reduced by 1/2% (half



percent) of the total contract price per week of delay or part thereof subject to a maximum of 5% of the total contract price, by way of reduction in price for delay and not as penalty.

5.0 Guarantee for Warranty

The contractor shall guarantee the equipment and the workmanship of the elevator for period of 12 months from the date of commissioning of the elevator. The Guarantee shall be furnished in non-judicial stamp paper of Rs.80/- in NLCIL format.

6.0 Contract Performance Guarantee:

The rendered work shall be guaranteed for a period of 12 months from the date of completion of work. Contract performance Bank Guarantee for faithful performance covering delivery obligation as well as warranty is to be furnished by the contractor at a value of 10 % of total contract value.

7.0 PERIOD OF CONTRACT

8.0 Payment Terms:

8.1 Civil Structural Work:

- 8.1.1 Payment upon reaching ground floor level and completion of structural works: 20% of total civil portion value to be released.
- 8.1.2 Payment upon reaching second to fourth floor level and completion of structural works: 20% of the total Civil portion value to be released.
- Payment upon reaching fifth to seventh floor level and completion of structural works: 20% of the total Civil portion value to be released.
- Payment upon completion of ACC blocks works (including plastering) up to seventh floor: 20% of the total Civil portion value to be released.
- 8.1.5 Payment upon completion of finishing works: 10% of the total Civil portion value to be released. Also, 100% payment of the embedded paint value to be released upon fully completion of Embedded paint work.
- 8.1.6 Payment upon completion of all Civil works: 10% of the total Civil portion value to be released.

8.2 Electrical Work:

- 8.2.1 Supply of Elevator: 60% of the total elevator portion value to be released upon delivery of the elevator at the site.
- 8.2.2 Elevator Erection: 20% of the total elevator portion value to be released upon completion of elevator erection works.
- 8.2.3 Elevator Commissioning: 20% of the total Elevator portion value to be released upon successful commissioning of the elevator.

9.0 Security Deposit:

The EMD Bank guarantee No: 101571125000018 dated 24.01.2025 for a value of Rs. 3,76,000/- valid upto 21.10.2025 and claim upto 21.01.2026 from Indian Overseas Bank, Surampatti, submitted by you hereby accepted and retained as Initial Security deposit (ISD) for the work.

You are requested to furnish a fresh Bank Guarantee (e-BG Preferably) for a value of Rs. 7,17,050/-(5% of the GeM Sanction Order of Rs 1,43,41,000 Including GST) valid up to the finalisation of the agreement or up to the period of six months from the original date of completion of the work whichever is earlier, as per the Clause No 13.6 General condition of the contract, towards Security Deposit (SD) within 10 (ten) days from the date of LOA.
