**Basis for Opinion**

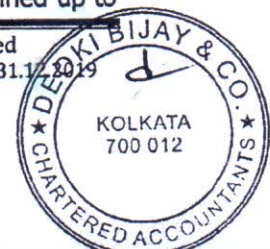
The Board of Directors are also responsible for overseeing the Company's financial reporting process.

**Opinion**

We have audited the accompanying Statement of Consolidated Financial Results of **R S Software India Limited** ("the Company") and its subsidiaries Responsive Solution Inc., R.S. Software (Asia) Pte Limited and Paypermint Private Limited (the Company and its subsidiaries together referred to as "the group") for the quarter ended December,2019 and for the period April 1, 2019 to December 31, 2019 ("the Statement") being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us, and based on the consideration of the reports of the other auditors on separate financial statements/ financial information of subsidiaries :-

- a. includes the results of subsidiaries Responsive Solution Inc., R.S. Software (Asia) Pte Limited and Paypermint Private Limited.

#### Other Matters

The Interim Consolidated Financial Results include the audited Interim Financial Results of Responsive Solution Inc., R.S. Software (Asia) Pte Limited and Paypermt Private Limited, the subsidiaries, whose interim Financial Statements reflect Group's share of total assets of Rs. 3094.56 lacs as at December 31, 2019, Group's share of total revenue of Rs. 29.35 lacs and Rs. 66.07 lacs and Group's share of total loss after tax of Rs. 237.39 lacs and Rs. 652.16 lacs for the quarter ended December, 2019 and for the period April 1, 2019 to December 31, 2019 respectively, as considered in the consolidated Financial Results, which have been



audited by their respective independent auditors. The independent auditors' reports on interim financial statements of these entities have been furnished to us and our opinion on the consolidated Financial Results, in so far as it relates to the amounts and disclosures included in respect of these entities, is based solely on the report of such auditors and the procedures performed by us are as stated in paragraph above.

Our opinion on the Interim Consolidated Financial Results is not modified in respect of the above matters with respect to our reliance on the work done and the reports of the other auditors and the Financial Results certified by the Board of Directors.
