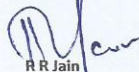

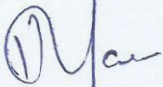

Opinion

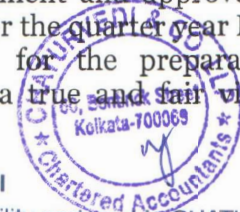
Basis for Opinion
