<b>Brief details of litigation viz.</b> name(s) of the opposing party, court/ tribunal/agency where litigation is filed, brief details of dispute/litigation;	<p><b>Opposing Party:</b> Asia Satellite Telecommunications Company Limited, a Company incorporated in Hong Kong</p> <p><b>Court / tribunal / agency where litigation is filed:</b> The Opposing Party filed an Arbitration Proceedings at Singapore International Arbitration Centre ("SIAC"), praying for an Arbitration in terms of SIAC's Expedited Procedures as provided under rule 14 and Schedule 3 of the Singapore International Arbitration Centre ('SIAC') Rules ('Rules').</p> <p><b>Brief details of dispute / litigation:</b> Arbitration has been invoked by the Opposing Party under the Transponder Capacity Agreement ('TCA') executed between the parties, with respect to the outstanding amount, as alleged to be payable by the Company. Company became cognizant of the said Notice on February 9, 2026. The said TCA has already been terminated.</p>
<b>Expected financial implications, if any, due to compensation, penalty etc.;</b>	<p>The Opposing party has claimed that the amount in dispute is to the tune of USD 1,553,482.05/- (including Interest and liquidated amount). The Company shall be taking necessary advice from the legal counsel on the said matter and will defend the matter accordingly. Subject to contractual terms, the arrived amount with such deductions as may be agreed would be payable by the Company. The financial impact will be limited to the extent of the final order.</p>
