Sub: Intimation of receipt of demands/penalties by West Bengal VAT/Customs Authorities.
Ref: Disclosure pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

Dear Sir/Madam,

This is in reference to the captioned subject and in compliance of Regulation 30 of the SEBI (Listing Regulations) read with SEBI Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 and circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2025/25 dated February 25, 2025, as amended from time to time, we do hereby inform that, the Company has received following from Directorate of Commercial Taxes, Government of West Bengal (Officer of the Charge Officer) and Commissioner of Customs (Export), Mumbai pertaining to business transactions/activities done by the Company a decade before:

- a) Letter received on 26th June, 2025 for demand of Rs. 44.23 lakhs (and interest of Rs. 24.42 lakhs thereon) towards tax payable on goods imported in territory of West Bengal, pursuant to a recent order passed by the Hon'ble Division Bench of High Court at Calcutta in the matter of State of West Bengal & Ors vs Pepsico India Holding Private Limited & Ors.
- b) Order-in-original issued by Commissioner of Customs (Export) received on 26th June, 2025 imposing penalty of Rs. 17.30 lakhs (along with applicable interest payable thereon) towards recovery of the customs duty under Section 114A of the Customs Act, 1962 and of Rs. 11 lakhs towards redemption fine under Section 125 of the Customs Act, 1962.

Both the above demands are being contested by the Company despite the same are not likely to impact the Company or activities thereof. The same are being reported applying the criteria specified in Regulation 30 (4) of Listing Regulations, read with Schedule III Part B para 8 of Listing Regulations.

Kindly do take the above information on your record and oblige.
