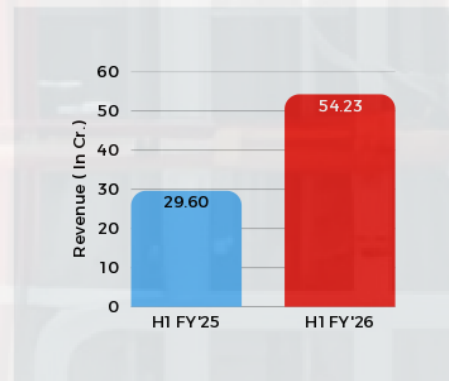

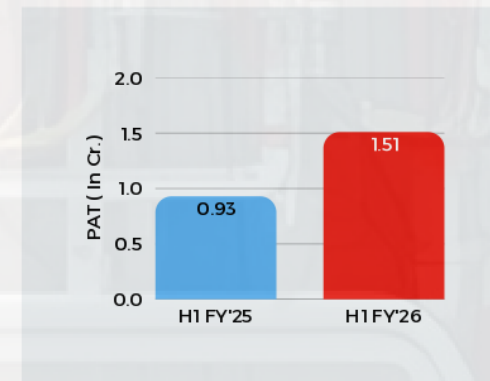

H1-FY26 Business Highlights:

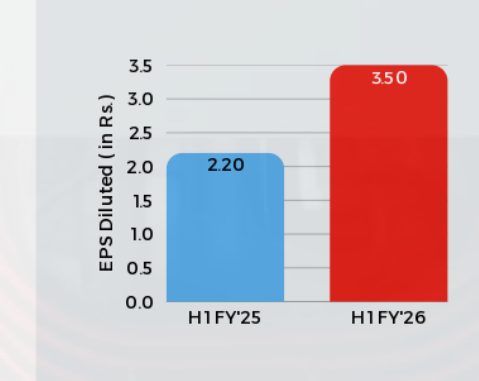
