**Summary of Proceedings of the 22nd Annual General Meeting of Rail Vikas Nigam Limited
(RVNL) held on Thursday, 28th August, 2025 at 11:30 A.M.**

The 22nd Annual General Meeting (Meeting) of the Members of Rail Vikas Nigam Limited (RVNL) was held on **Thursday, 28th August, 2025 at 11:30 A.M. (IST)** through Video Conferencing (VC) / Other Audio-Visual Means (OAVM) for which purpose the registered office of the Company situated at 1st Floor, August Kranti Bhawan Bhikaji Cama Place, R. K. Puram, Delhi-110066 was deemed as the venue of the meeting.

Brief proceedings of the same are as under:

The Meeting commenced at 11:30 A.M.

Shri Pradeep Gaur, Chairman & Managing Director chaired the proceedings of the meeting and welcomed the Members who joined through VC/OAVM. The Chairman then introduced the Board Members, Key Managerial Personnel, Statutory Auditors, Secretarial Auditors and Scrutinizer present in the meeting including the Chairman of Audit Committee and Stakeholders Relationship Committee.

126 members attended and participated in the meeting. The quorum as required under the Companies Act was present throughout the meeting.

It was informed that the statutory registers required to be there during the AGM was made available for inspection on RVNL's website.

The Chairman's Statement was read by the Chairman apprising the financial and physical performance of the Company for the financial year 2024-25, details of SPVs, Human resource development, Corporate Social Responsibility, MoU performance and Corporate Governance.

With the consent of all the members present, the Notice of AGM and the Annual Report of the Company for the year 2024-25 containing the Directors Report, Audited Financial Statements (Standalone and Consolidated), Auditors' Report and C&AG comments thereon were taken as read. The Company Secretary read out the business items proposed for approval by members at the meeting.

The Company Secretary further informed that the facility of casting votes by remote e-voting through CDSL Portal provided to Members, commenced from Monday, 25th August, 2025 (09.00 AM IST) and ended on Wednesday, 27th August, 2025 (05.00 PM IST). In addition, facility for e-voting was also provided during the AGM to those members who did not cast their votes through remote e-voting. The members were informed that the Company had appointed M/s. Kumar Naresh Sinha & Associates, Practicing Company Secretary, to scrutinize the remote e-voting as well as e-voting at the AGM in a fair and transparent manner.

The shareholders, who had registered themselves as speakers in advance, were then invited to raise their questions.

Thereafter, the Chairman responded to the queries raised/clarifications sought by the members on the various issues which inter-alia included the future prospects of the Company including new opportunities/Future plan, Status of MoUs signed, Foreign presence, status of ongoing projects, Corporate Social Responsibility, Whistle blower policy etc.
