SUMMARY PROCEEDINGS OF THE 13TH ANNUAL GENERAL MEETING

The 13th Annual General Meeting (AGM) of the members of the V-MARC India Limited (“the Company”) was held on 25th September, 2026 at 11:00 A.M (IST) through Video-Conferencing (“VC”)/ other Audio-Visual Means (“OAVM”) using Bigshare Services Private Limited.

The meeting was commenced at 11:00 A.M (IST) and concluded at 11: 38 A.M (IST).

Mr. Anuj Ahluwalia, Company Secretary & Compliance Officer of the Company welcomed everyone in the Thirteenth Annual General Meeting of V-MARC India Limited.

All the members were informed that the Thirteenth AGM was held through electronic mode, without the physical presence of the members at common venue, in accordance with the applicable circulars issued by the Ministry of Corporate Affairs (“MCA”) and the Securities and Exchange Board of India (“SEBI”). It was further informed that as per the said circulars, the Notice of the AGM and Annual Report of the Company for financial year 2025-26 were sent to shareholders via email on August 31, 2026 to all those members whose email ids were registered with the Company or with the Depository Participants.

Mr. Vikas Garg, Chairman and Managing Director of the Company Chaired the Meeting.

After confirming that requisite Quorum is present then with the Permission of the Chairman, he called the Meeting in Order.

Directors, Auditors and Chief Financial Officer were in attendance. The Chairman of the Audit Committee, Nomination & Remuneration Committee, CSR Committee, Risk management Committee and Stakeholder Relationship Committee were also present.

All the Shareholders were also informed that all the members who have joined this meeting are by default placed on mute, to avoid any disturbance from background noise and ensure smooth and seamless conduct of the meeting and the e-voting window will be open on the Bigshare i-voting platform for 15 minutes from the conclusion of the AGM, and requested members to cast their votes, in case they had not cast vote during the remote e-voting period.

Then he requested the Chairman and Managing Director-Mr. Vikas Garg to take up the proceeding further.

Mr. Vikas Garg welcomed all the shareholders and gave the speech and with the consent of the Shareholders, Managing Director’s Speech was taken as Read. Then, Company Secretary took the proceedings further and with the consent of the members present at the meeting, Notice convening the Annual General Meeting, Director’s Report and Financial Statements for the Financial Year ended March 31, 2026 are taken as read since they are already circulated in advance.
