Sub: Consolidated Scrutinizer's Report on Remote E-voting and Postal ballot conducted pursuant to the provisions of Section 108 and 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014.

I, Uday Dave, Partner of M/s. Parikh Dave & Associates, Practicing Company Secretaries, having its office at 5-D, Vardan Exclusive, Next to Vimal House, Nr. Stadium Petrol Pump, Navrangpura, Ahmedabad - 380014, have been appointed as the Scrutinizer by the Board of Directors of **ADI FINECHEM LIMITED**, to conduct and scrutinize the Remote E voting process and Postal Ballot process for resolutions contained in the Notice dated July 12, 2016.

I submit my report as under:

1. The Company has completed the dispatch of Notice along with the Postal Ballot forms and prepaid postal envelope returnable to the Scrutinizer on Friday, August 12, 2016 to all its entitled members / beneficiaries as on cutoff date i.e August 6, 2016.
2. The shareholders of the Company holding shares as on the "cut-off date" i.e August 6, 2016 were entitled to vote on the resolutions as contained in the notice of postal ballot dated July 12, 2016.
3. The voting by postal ballot and Remote E voting was kept open from 9.00 A.M. (IST) on August 13, 2016 to 5.00 P.M. (IST) on September 11, 2016.
4. The Company availed the services of M/s. Central Depository Services (India) Limited (CDSL) for providing remote E-voting facility to the members of the Company.
5. The votes cast under remote e-voting facility were unblocked on September 11, 2016 at around 5.10 P.M. (IST) in the presence of two witnesses Mr. Neel Shah and Mr. Bhavik Parikh who were not in the employment of the company.
6. All Postal Ballot forms received on or before the last date determined for receipt of Postal ballot forms were considered for scrutiny.
7. 46 Envelopes containing the Postal Ballot forms were returned undelivered. Those envelopes were not opened and will be taken up for destruction by the Company after announcement of the results.

8. With regard to the Postal ballots, the ballot papers were diligently scrutinized by me and were reconciled with the records maintained by the Company / Registrar and Transfer Agent. The votes tendered through remote E voting were also scrutinized by me, based on the download from CDSL E-voting portal / system. The voters were also scrutinized for the purpose of eliminating the duplicate voting i.e through remote E voting as well as through postal ballot.
9. No ballot paper was found defective*.
