Sub: Request Letter for re-classification from Promoter Category shareholder to Public Category shareholder in SAB Events & Governance Now Media Limited ("Company") as per Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015.

I, MARKAND NAVNITLAL ADHIKARI, S/o Late Sri. NAVNITLAL ADHIKARI, R/o 5th Floor, Adhikari Villa, 46, Hathkesh CHS, Road No. 7, Nr. J. N. School, JVPD, Vile Parle (West), Mumbai - 400049 am a Promoter of SAB Events & Governance Now Media Ltd. presently holding 4,81,589 No. of equity shares (4.59% of the total shareholding/share capital of the Company).

I was classified as a Promoter of the Company since incorporation. However, over the past two years, I have not been associated in any manner with the business and operations of the Company. I had resigned from my position as a non-executive Director of the Company a year ago, having made a conscious and personal decision to withdraw from corporate affairs and managerial responsibilities.

I now at the age of 68 years wish to lead a life of simplicity, dedicating my time to social service and prayer, and remaining detached from all business and administrative engagements. Accordingly, I hereby express my desire to be reclassified from "Promoter" to "Public Shareholder" of the Company.

Further, I confirm that I do not have any right to appoint any Director of the Company, nor do I possess any ability to control the management or policy decisions of the Company in any manner whatsoever, including by virtue of my shareholding. I also affirm that none of my acts or decisions will influence the management or decision-making process of the Company in any way.

For clarity, my son Mr. Kailasnath Adhikari (DIN: 07009389) serves as the Managing Director of the Company. However, he functions independently under the authority of the Board. I do not influence his decisions, nor am I a party to any arrangement or

understanding with him regarding the affairs of the Company and we do not act in concert for voting or management matters.

I hereby confirm that:

1. I do not hold more than 10% voting rights in the Company;
2. I do not exercise direct or indirect control over the affairs of the Company;
3. I do not have any special rights through any formal or informal arrangements, including by way of shareholder, Board or voting agreements.
4. I am not represented on the Board of Directors of the Company, including not having a Nominee Director;
5. I do not act as a Key Managerial Personnel of the Company;
6. I am not a wilful defaulter and not a fugitive economic offender.

I further state that:

1. There is no pending Regulatory Action against me;
2. I shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of the SEBI LODR Regulations at all times from the date of reclassification, failing which I shall be reclassified as promoter of the Company;
3. I shall comply with the conditions mentioned in sub-clauses (iv) and (v) of clause (b) of Regulation 31A(3) of the SEBI LODR Regulations for a period of not less than three years from the date of reclassification, failing which, I shall be reclassified as promoter of the Company.

I request you to take necessary steps for my re-classification from promoter category shareholder to public category shareholder in SAB Events & Governance Now Media Limited and also assure you my full cooperation in all the ways during the entire process of re-classification and I will submit the necessary documents if any required by the Statutory Authorities during the process of approval

Please do the needful at the earliest possible.
