1. Financial results submitted in XBRL with discrepancies

With reference to our earlier reply dated June 30, 2025 and July 14, 2025 to your email dated June 26, 2025 and August 18, 2025 we wish to clarify that the Consolidated Financial Results in PDF format, as approved by the Board of Directors at its meeting held on May 27, 2025, are correct and should be referred to as the final and accurate financial information of the Company for the quarter and year ended March 31, 2025.

Unfortunately, during the preparation of the XBRL submission, an inadvertent manual tagging error occurred, which resulted in a mismatch between the XBRL and PDF versions of the financial results. We acknowledge this lapse and have taken immediate corrective action. The necessary corrections have been made in the XBRL file, and the rectified version has been resubmitted to the Stock Exchange on August 21, 2025.

We deeply regret any inconvenience caused and assure you that we have initiated internal checks to strengthen our disclosure controls and avoid such discrepancies in the future.
