INVESTMENT COMES AS DIGITAL INFRA DEMAND RISES

Canada's La Caisse invests ₹12,100 cr for 24% in Altius Telecom

LA CAISSE, THE global investment group formerly known as Caisse de Depot et Placement du Quebec (CDPO), has invested around ₹12,100 crore (CAD 1.76 billion, or about \$1.3 billion) to acquire a 24% stake in Altius Telecom Infrastructure Trust, India's largest independent telecom tower platform, alongside Brookfield.

The transaction has been completed, with Brookfield continuing as Altius' largest investor alongside La Caisse and existing shareholders affiliated with GIC and British Columbia Investment Management Corporation (BCI).

The investment comes as rising mobile data consumption and the continued rollout of 5G drive demand for telecom and digital infrastructure in India, the world's second-largest telecommunications market.

"As India's economy grows and more people and businesses rely on higher use of mobile data, the infrastructure behind those connections needs to keep pace," Emmanuel Jaclot, executive vice-president and head of

infrastructure and sustainability at La Caisse, said.

La Caisse, Canada's second-largest pension manager, has experience investing in telecom towers and digital infrastructure globally.

Jaclot said the investment was being made alongside Brookfield and other institutional partners with which it has longstanding relationships. Sam Pollock, CEO of Brookfield's Infrastructure group, said Altius had built a scaled, nationwide platform that was well positioned to

cater to India's growing mobile connectivity and 5G requirements. "La Caisse's investment brings another long-term institutional partner to the platform and reflects confidence in the strength of the business," Pollock said.

Altius owns and operates more than 258,000 telecom towers and sites across India, providing infrastructure used by mobile operators to deliver 4G and 5G services. Its portfolio includes ground-based towers, rooftop towers, camouflage towers and cell-on-wheels.

AI Express pilots seek 70-hour allowance

AIR INDIA EXPRESS pilots are seeking a minimum flying allowance of 70 hours under the airline's revised pay structure, even as the carrier has raised pilot salaries by 10-15% on average across cadres, according to airline sources.

The revised structure, announced a couple of weeks ago, includes a variable component linked to flying hours. Pilots currently receive a minimum flying allowance equivalent to 40 hours, regardless of whether they fly 40 hours or fewer in a month. They are now seeking to raise the guaranteed minimum to 70 hours, in line with IndiGo's structure.

The minimum flying allowance at Air India Express was 70 hours before the Covid-19 pandemic. It was subsequently reduced to 20 hours as flight operations remained subdued and was later rationalised to the current 40-hour level. As per airline sources, pilots have welcomed the salary increase but are seeking a higher guaranteed flying-hours component. The airline, however, believes its higher base salaries make overall compensation comparable with IndiGo, where the fixed base salary is relatively lower.

Auto industry calls for shift from 'Make in India' to tech ownership

THE AUTOMOTIVE INDUSTRY wants localisation to move beyond manufacturing and import substitution to the design, development and ownership of technologies that will power the next generation of vehicles, as India seeks to emerge as a global automotive manufacturing and technology hub.

The call, made at the 66th annual session of the Automotive Component Manufacturers Association of India (Acma), comes as automobiles undergo a technology shift towards electrification, software-defined vehicles, advanced electronics and connected systems. Industry leaders said India has built manufacturing scale and a deep supplier base, but needs to capture a larger share of the value created by the technologies going into vehicles.

Maruti Suzuki India Managing Director and CEO Hisashi Takeuchi said deeper localisation would also have to extend beyond large automakers and Tier-1 suppliers to Tier-2 and Tier-3 vendors, with greater focus on engineering, quality and productivity. "Unless our Tier-2 and Tier-3 suppliers are capable, we can't produce world-class quality," Takeuchi said.

The industry's ambition is, therefore, shifting from making products developed elsewhere to developing technologies in

India that can be used and exported globally. Society of Indian Automobile Manufacturers (SIAM) President Shailesh Chandra said India should increasingly seek to become a technology creator rather than merely a manufacturing base for global technologies. "We should not aspire merely to manufacture globally developed technologies in India. We should increasingly aspire to develop technologies in India for the world," Chandra, who is also MD of Tata Motors Passenger Vehicles and Tata Passenger Electric Mobility, said.

vehicles is making semiconductors, power electronics, batteries, electric motors, sensors, software and connected systems increasingly important. "We should follow a simple principle: design in India, develop in India, manufacture in India and export from India," Chandra said.

The gap between India's manufacturing capabilities and technology ownership is visible in component trade. Hyundai Motor India managing director and CEO Tarun Garg said India imported auto components worth around \$25.4 billion in FY26, against exports of about \$24 billion, resulting in a trade

deficit of roughly \$1.4 billion. More importantly, he said, exports remain concentrated in relatively mature technologies, while imports are increasingly skewed towards advanced and higher-value tech. "Technology ownership is essential for strategic independence," Garg said, calling for greater domestic capabilities in semiconductors, rare-earth magnets, power electronics and battery cells.

Acma President Vikram Pati Singhania said the next phase of the Make-in-India programme should focus on building intellectual property and technology capabilities within India.

Two-wheeler market sustains growth

THE TWO-WHEELER market maintained its growth momentum in August, with most major manufacturers reporting higher domestic sales, led by strong performances from TVS Motor, Royal Enfield, Suzuki Motorcycle India and Hero MotoCorp.

Hero MotoCorp, the country's largest two-wheeler maker by volumes, reported a 4.5% increase in domestic sales to 542,305 units in August, from 519,139 units a year earlier.

Honda Motorcycle & Scooter India's domestic dispatches rose 8% to 517,329 units from 481,021 units in August 2025. The company attributed the growth to sustained demand across commuter motorcycles and scooters, supported by models such

as the Activa range, Shine, SP125 and Unicorn.

TVS Motor Company reported an 18% increase in domestic two-wheeler sales to 433,796 units from 368,862 units a year earlier. The domestic market accounted for about 73% of the company's total two-wheeler sales during the

month. Electric two-wheelers continued to significantly outperform the broader market. TVS sold 59,453 electric two-wheelers in August, up 137% from 25,138 units a year earlier, as adoption of electric mobility expanded across urban and semi-urban markets. Bajaj Auto reported

domestic two-wheeler sales of 201,898 units in August.

Royal Enfield's domestic sales rose 11% year-on-year to 114,204 units from 102,876 units a year earlier. The growth came on a high base, with August 2025 having been a record month for the company at the time, surpassing its previous monthly high of 110,574 units recorded in October 2024. The Chennai-based manufacturer has sustained its domestic growth into the current financial year. On a year-to-date basis, domestic volumes rose 28% to 520,695 units. Suzuki Motorcycle India reported a 13% rise in domestic sales to 103,118 units in August from 91,629 units a year earlier.

The company's spare-parts business also posted its highest-ever August revenue at ₹103.3 crore, up 21% from ₹85.56 crore in August 2025.

Dealer profitability key Fada priority

DEALER PROFITABILITY will be a key priority for the Federation of Automobile Dealers Associations (Fada) as the auto market enters a phase of broad-based growth, with the industry body also planning to pitch dedicated automobile retail zones across major metros to the government.

Sai Giridhar, president, Fada, said higher volumes are supporting dealer margins, but profitability remains uneven across brands. "Without a profitable dealer, I don't think anything would work," he said, adding that Fada will work with original equipment manufacturers (OEMs) to improve dealer profitability across segments.

Giridhar said Fada plans to

work with OEMs and state and central governments to develop dedicated automobile retail zones, primarily on government land on the outskirts of major cities. The proposed clusters would bring together showrooms, workshops, training academies and ancillary units, along with facilities such as solar power and water harvesting.

The proposal will be submitted to the government and could also help address the industry's growing manpower and skill requirements through training and upskilling programmes, he said. The transition to electric vehicles (EVs), meanwhile, will require an adjustment in dealership economics, particularly as after-sales revenue from EVs is lower than that from internal-combustion engine (ICE) vehicles.

CSK's worst IPL finish hits FY26 profit of promoter

FOR CHENNAI SUPER KINGS, the disappointment of its worst-ever IPL finish in 2025 did not end with the team's exit from the T20 league. The poor performance on the cricket field has now shown up in the books of its promoter, Chennai Super Kings Cricket (CSKCL), with a sharp fall in central rights income dragging down both revenue and profitability in FY26.

CSKCL's standalone revenue fell marginally to ₹636 crore from ₹644 crore in the previous year, according to its annual report. The decline was primarily due to a steep reduction in central rights income, which fell to ₹38 crore in FY26 from ₹46 crore in FY25. "The reduction in central rights income is due to the standing of the team at the tenth position in IPL 2025 as against the fifth position in IPL 2024," CSKCL said.

Central rights income is the share of revenue a franchise receives from the IPL's centrally negotiated broadcasting and digital media rights. Consequently, profit after tax fell to ₹162 crore from ₹181 crore in FY25. Despite the sharp fall in rights income, revenue from operations increased to ₹622 crore from ₹615 crore. The company said the decline in central rights income was more than offset by higher sponsorship income and other tournament-related income. Other income declined to ₹14 crore from ₹29 crore, primarily due to a decrease in interest income.

दिल्ली व्यापार सुगमता विधेयक-2026 को मंत्रिमंडल की मंजूरी एकल खिड़की व्यवस्था लागू होगी, प्रक्रिया पारदर्शी रखने का दावा

नई दिल्ली, 2 सितंबर।

दिल्ली सरकार ने राजधानी में कारोबार करने की प्रक्रिया को आसान, तेज और अधिक पारदर्शी बनाने की दिशा में बड़ा कदम उठाया है। मुख्यमंत्री रेखा गुप्ता की अध्यक्षता में गत मंगलवार को हुई मंत्रिमंडल की बैठक में दिल्ली व्यापार सुगमता विधेयक, 2026 को मंजूरी दी गई। दिल्ली सरकार का कहना है कि कारोबारियों को अब सभी जरूरी अनुमतियां, पंजीकरण लेने की सुविधा एकल खिड़की पर मिलेगी। दिल्ली मंत्रिमंडल की मंजूरी के बाद विधेयक को अब भारत सरकार के गृह मंत्रालय को भेजा जाएगा।

मुख्यमंत्री ने कहा कि यह विधेयक भारत सरकार की नियमन में कमी और अनुपालन का बोझ घटाने की पहल के दूसरे चरण के तहत तैयार किया गया है। मुख्यमंत्री ने कहा कि विधेयक के तहत एकल खिड़की प्रणाली (सिंगल विंडो सिस्टम) स्थापित की जाएगी। इसके तहत एक ऑनलाइन, सरल और उपयोग में आसान व्यवस्था बनाई जाएगी, जहां कारोबारी अपने कारोबार से संबंधित अनुमतियों,



सरकारी दफ्तरों के चक्करों से छुटकारा

मुख्यमंत्री ने कहा कि दिल्ली सरकार ऐसी व्यवस्था तैयार कर रही है जिसमें कारोबारियों और उद्यमियों को अलग-अलग सरकारी कार्यालयों के चक्कर न लगाने पड़ें। एक ही जानकारी बार-बार जमा न करनी पड़े और आवश्यक अनुमतियों के लिए लंबे समय तक इंतजार न करना पड़े।
