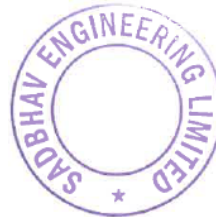
Considering the same, we humbly request you not to consider this error as non-compliance.

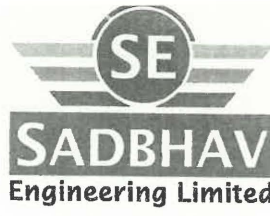
