**CORRIGENDUM TO THE NOTICE OF EXTRA-ORDINARY GENERAL MEETING DATED

The EGM Notice has already been dispatched / e-mailed to all the Members of the Company on 14th January, 2026 in due compliance with the provisions of the Companies Act, 2013 read with relevant Rules thereunder. Members are aware that the Company is offering Remote E-Voting facility to its Shareholders on all the Resolutions proposed to be transacted at the EGM. However, to enable the Shareholders to exercise their Voting Rights through Remote E-Voting facility or at the EGM through VC/OAVM on an informed basis, the Company deems it appropriate to bring the latest factual position, as mentioned below to the notice of the Members of the Company through this Corrigendum to the EGM Notice ("Corrigendum").

The Company through this Corrigendum wishes to bring to the attention of the Members, certain changes in the Item No. 3 & 4 related to Preferential Issue of Equity Shares and in the Explanatory Statement of the said Item. Below are the modifications:

1. There were certain changes in valuation report dated 12th January, 2026. The changes are as under:
 - a. The report has been updated to reflect audited financials as on 30th September, 2025, instead of unaudited financials as on 30th September, 2025.
 - b. On page 12, point number 9, the figure has been corrected to Rs. 142.59 Crores from the previously stated Rs. 142.59 Lakhs.

Furthermore, we assure you that the minimum price calculated is correct in accordance with SEBI Regulations and the price of Rs. 109.11/- remains unchanged.
